LCOA Golf Cart Operation and Registration within Long Creek Subdivision

For the purposes of this policy, the term "Golf Cart" shall include three (3) or four (4) wheeled/off road vehicles and other similar motorized vehicles.

"Golf Cart" operation on The Bandit Golf Course, including its pathways or property, is controlled exclusively by Foresight Golf Partners 2001, Ltd. Check with the Bandit Golf Course Pro Shop for guidelines that are separate and apart from the guidelines of Long Creek Owners Association.

"Golf Cart" operation on the streets and other common areas of Long Creek Subdivision is a privilege, not a right, controlled by the LCOA's membership for its individual and collective welfare.

General Purpose and Operational Guidelines for Golf Cart Operation:

To reduce the risk of accidents and injury or death:

- "Golf Cart" is to be operated by licensed operators 16 years and older with a valid motor vehicle license, except when adult supervision is in the cart during operations.
- Never travel at speeds too fast for the terrain, visibility conditions, or driver's experience.
- Driver should take extra caution in congested areas, when operating in reverse, going around curves and when driving on wet, rough, or loose surfaces, or when other "Golf Carts" are in close proximity.
- Individuals occupying a "Golf Cart" shall not exceed the number of seats of the "Golf Cart".
- Speeding, driving erratically, standing on a "Golf Cart", towing or being towed by a "Golf Cart" or any other dangerous act is prohibited.
- "Golf Carts" operated at night MUST have front AND back illumination.

"Golf Cart" operation is subject to the following:

- No "Golf Cart" may operate on the streets or other common areas of Long Creek Subdivision without being permitted.
- Each "Golf Cart" owner, who is a member of LCOA or a tenant of a member of LCOA, shall complete and submit an application to the Long Creek Owners Association Board of Directors for a "Golf Cart" use permit.
- As a part of the application process, "Golf Cart" owner's use of a "Golf Cart" is an
 affirmative indication that s/he, as well as any authorized driver of "Golf Cart" has
 reviewed www.NationalGolfCartAssociation.com "Safety and Accident information", and
 will adhere to its suggestions.
- Upon approval of application, LCOA shall provide permit decal at no charge.
- Permit decal must be placed in a clearly observably place on the "Golf Cart".

Non-Compliance:

- First offense –Warning
- Second offense Cart privileges are withdrawn. No reapplication for six (6) months.; and, a fine of seventy-five dollars (\$75.00).

Exceptions:

• Applications for exceptions to the guidelines for permitted operators may be submitted to the Long Creek Owners Association Board of Directors for consideration.

NOTE: BE AWARE THAT "GOLF CART" OWNERS ARE PERSONALLY RESPONSIBLE FOR ANY AND ALL DAMAGE TO LIFE OR PROPERTY INVOLVING THEIR CART; AND THE RULES DO NOT TRANSFER ANY LIABILITY TO LONG CREEK OWNERS ASSOCIATION.
